Substance Misuse

as a Secondary Problem

Although clients can seek treatment specifically for their substance misuse, it is often an issue that comes to light during interventions for other problems, which derails the therapy from proceeding in a helpful way. This one-day workshop helps mental health professionals address issues of dual diagnosis, common difficulties and frustrations of working with this client group.

One of the most difficult issues can be engaging the client to tackle their substance misuse. To this end a novel motivational method will be illustrated (The Decisional Matrix), designed to focus on the functions and consequences of substance use for the individual client, and reveal the practical, social and emotional tasks to be undertaken.

Therapists will learn the main effects of different chemicals on brain functioning (e.g. alcohol, marijuana, Spice, cocaine). They will also be made aware of the evidence-based treatment options. The workshop will include using modified CBT in working with triggers, cravings and behaviours, and alternative coping strategies to alcohol and drug use.

- · Common effects of alcohol and substances on mental health
- Specific effects of alcohol, marijuana & cocaine on brain functioning
- How do you know when substance use is a problem? Ongoing assessment
- Working with both the behaviours & underlying issues, & making links b/n the two.

- A Motivational Enhancement approach: The Cycle of Change, The Decisional Balance (Consequences) exercise, Understanding & working with the functions & consequences of substance use for clients, Motivational Interviewing skills & strategies
- Use of psychoeducation
- · Identification & management of triggers & cravings
- Alternative coping strategies
- · Self-care, affect regulation, relationship management

Alison Hunt, MSW has over 26 years' experience working with clients with substance abuse issues, supervising & training other clinicians, and designing and managing treatment programmes. Currently, she provides training for counselling staff at THT, and at services for dually-diagnosed clients. Her past positions have included Clinical Director of an EAP, Treatment Manager of residential and outpatient alcohol & drug services in both the voluntary & private sectors, and Treatment Manager of the Max Glatt Centre at HMP Wormwood Scrubs.
